EMERGENCY ACTION PLAN

- In the event of an accident resulting in a casualty, whoever is present should alert other members of staff on radio channel 1, request the assistance of a full first aider if there is not one at the scene and request additional first aid equipment if required.
- All unnecessary communications via radio should stop in order that the channel is kept open.
- After identifying the need for an ambulance, the first aider should designate a helper to make contact with the emergency services via the nearest means of communication and have them report back to the first aider to confirm that contact has been made.
- An additional designated person must be sent to meet the ambulance at the garden entrance and guide them to the location of the casualty(s).
- If the casualty's condition worsens or the situation changes then the designated helper should contact the emergency services to relay the updated information.
- The Garden Curator, Supervisor and staff at the admissions desk (when the garden is open) should be informed in order to assist in coordination of the emergency procedures.
